PAYG Withholding variation to the rate of withholding for superannuation income stream beneficiaries who turn 60 during the financial year (AU)

Starts1 July 2018. This instrument is made under section 15-15 of Schedule 1 to the Taxation Administration Act 1953 ('TAA'). The pay as you go withholding system allows many taxpayers to make provision for their income tax liabilities by requiring payers to withhold amounts from certain payments, including taxable superannuation income stream benefits. This instrument provides for a more accurate amount of withholding for the relevant payees by taking into account all of their circumstances.

Product Emissions Standards (Customs) Charges Regulations 2018 (AU)

The purpose is to prescribe the amount of charge to be imposed on the import of emissions-controlled products. The charge is set at 0.45% of the value of the product, subject to the operation of a high item value threshold and an importation threshold. The high item value threshold limits the amount of charge on any one item to ensure that importers of high value products do not face a disproportionate share of the costs of the scheme. The importation threshold is based on the sum of the product values of emissions-controlled products imported by a person each financial year and reduces the overall administrative costs of the scheme by ensuring that the cost of recovering a charge from an importer is not greater than the charge itself.

Product Emissions Standards (Excise) Charges Regulations 2018 (AU)

The purpose is to prescribe the amount of charge to be imposed on the **manufacture** of emissions-controlled products. The charge is set at 0.45% of the price of the product, subject to the operation of a high item value threshold and a manufacture threshold. The high item value threshold limits the amount of charge on any one item to ensure that manufacturers of high value products do not face a disproportionate share of the costs of the scheme. The manufacture threshold is based on the sum of the product values of emissions-controlled products manufactured by a person each financial year and will reduce the overall administrative costs of the scheme by ensuring that the cost of recovering a charge from a manufacturer is not greater than the charge itself.
