David will give a presentation to VADA Members on the soon to be released VicRoads Vehicle Report, a new report from the Victorian Government that will provide dealers and car buyers with a comprehensive vehicle history report including information on the cars specifications, Victorian transfer and registration history, registration history, PPSR report, history of Roadworthy inspections and importantly a history of a vehicle odometer reading using data generated by the VicRoads transfer system. The odometer history will also provide an odometer reading comparison of vehicles of similar size that have sold or been transferred in the preceding three months.

You can view the final VicRoads Vehicle Report offering and put questions to David about future VicRoads plans for the provision of vehicles sales and transfer data to dealers.
