- **Vehicle Removal Breach**
Instructions – Once opened also tag the following clauses within the IDR Builder, Clause(s): 4.2 (b) (iv) *in addition to including the repair, insurer and vehicle details.*

If an Insurer does not resolve your complaint favourably, please contact Vanessa and ask for the matching External Dispute Resolution (EDR) application form. VACC has also pre-built these applications forms which you can lodge with the Victorian Small Business Commission (VSBC) swiftly and without too much effort on your behalf.
