## The committee has focused upon:

- Improving Rules and Regulations Committee members participated in numerous official State and National working groups to bring about sensible, less cumbersome rules and regulations for industry.
- Red Tape Reduction Tenacious effort on many fronts to seek exemption from the Victorian State Government's 'Engineer's Registration Bill' which was designed for Civil and Construction engineers, but which may cause many professional engineers to leave the Automotive industry and increase the cost of modifying a vehicle. This is an ongoing fight
- National AVE Scheme (Fight for Equity) CVIAV is on the front foot with respect to ensuring that a fair national plan delivers the same cost and legal obligation outcomes for all vehicle modifiers wherever they trade in Australia.
