# If you are a Franchisee or Licensee, you must attend this seminar!

#### What is the issue?

Following recent high profile cases involving franchisees breaching their obligations as employers, on 1 March 2017, the Australian Government introduced a Fair Work Act amendments bill to protect vulnerable workers in workplaces operating under franchise agreements.

These amendments intend to hold franchisors and holding companies responsible for certain contraventions of the Fair Work Act by their franchisees. If the proposed amendments go through, franchisors most likely will establish extensive auditing, training, common payroll and other systems to ensure compliance by franchisees.

#### Who should attend?

Any automotive business, particularly those that that are franchise, agency or licensee based. The seminar will target business owners, Dealer Principals, Chief Financial Officers, General Managers and Human Resource officers.

Industry sectors that should attend include fuel retailers, new car, motorcycle, commercial vehicle and farm machinery dealerships, car rental companies, automotive repair workshops, fuel retailers, body repair shops and tyre dealers.

#### What will the seminar offer?

VACC Senior Workplace Lawyer, Gabriella Marton, will provide guidance to members to understand both their franchising and employment obligations regarding the proposed amendments. Gabriella will also speak about the experience of the VACC Industrial Relations Department in assisting franchisees audited by the Fair Work Ombudsman.

VACC Industry Policy Advisors John Khoury and Michael McKenna will all be attending to advise on Industry Specific issues including:

- Australian Consumer Law Review
- Licensed Vehicle Tester issues
- Access to Business Insurance for high-risk sectors
- VicRoads issues
