

Update: One change to COVIDSafe Settings that take effect in Victoria from 11:59pm tonight

The Acting Victorian Premier has today announced one change to the COVIDSafe Settings that will take effect in Victoria from 11:59pm tonight until 11:59pm Thursday 17 June 2021, being that **face masks will continue to need to be worn within Metropolitan Melbourne both indoors and outdoors**. Previously, face masks were only going to be required to be worn outdoors, where 1.5 metres social distancing could not be maintained.

People will still be able to leave their homes **for any reason** from 11:59pm tonight – with the previously announced easing of restrictions otherwise unchanged:

For Metropolitan Melbourne, whilst there will no longer be any restrictions on reasons for leaving home, a travel limit of 25km from home will apply. Travel outside the 25km limit will only be permitted:

- to access necessary goods and services where those goods and services cannot be accessed closer than 25km from home
- to visit an intimate partner, or person in their 'single bubble'
- for work and education
- care and compassionate reasons

Travel from **Metropolitan Melbourne to Regional Victoria** and from **Regional Victoria to Metropolitan Melbourne** will remain prohibited, **except** for:

- work or education
- necessary goods and services
- care and compassionate reasons
- to receive COVID-19 vaccination at the nearest vaccination centre from home.

All automotive business workplaces in both Metropolitan Melbourne and Regional Victoria may open subject to the following applicable COVIDSafe Requirements:

- **face coverings** – in **Metropolitan Melbourne, face masks will continue to need to be worn both indoors and outdoors**; and in **Regional Victoria** indoors, and outdoors where 1.5 metres physical distancing is unable to be maintained
- **density quotient of one person per 4 square metres** in shared spaces and publicly accessible areas at the work premises – and in addition:
 - those operating **food and drink facilities** (e.g. roadhouses) will be able to provide seated dining service with a maximum patron cap in **Regional Victoria** of 150 people per venue (75 indoors and maximum group size of 10); and in **Metropolitan Melbourne** of 100 people per venue (50 indoors and maximum group size of 10).

- those operating in an **office work environment** in **Regional Victoria** will be able to have a 50% return (or up to 20 people if total workplace is 40 or less); and in **Metropolitan Melbourne** a 25% return (or up to 10 people if total workplace is 40 or less).
- electronic record keeping through **Victorian Government QR Code App** (see previous [Bulletin](#) for further information) **will be required in all Victorian workplaces** (with very limited exemptions) for customers, visitors and employees. Further details will be released next week, following Government consultation with industry bodies.
- **COVIDSafe Plan** requirements continue to apply.

VACC recommends that the recent changes provide a good opportunity to review your COVIDSafe Plan to ensure it remains current and the requirements are being adhered to and communicated with all relevant staff.
