# Victorian Premier announces a further easing of restrictions from 6pm, 29 October 2021

The Victorian Premier yesterday <u>announced</u> that a further easing of restrictions will occur from **6pm**, **Friday 29 October 2021**, as the **80 per cent (16 years and over) double dose** vaccination target is reached. As part of the announcement, the Victorian Premier foreshadowed that under a <u>revised 'Roadmap'</u> – a further significant easing of restrictions in line with Phase D of the National Plan will occur when Victoria hits the **90 per cent double dose (12 years and over) target** [previously 80 per cent double dose (12 years and over)], with a current indicative date of **Wednesday**, **24 November 2021**.

The announcement confirmed that from 6pm, Friday 29 October 2021:

- Metropolitan Melbourne and Regional Victoria will be on the same level of restrictions meaning that the travel limitation between Metropolitan Melbourne and Regional Victoria will be removed
- Masks will no longer be required outdoors but will remain mandatory indoors.
- All automotive business will be able to operate, subject to the COVIDSafe Settings below.

#### **COVIDSafe Settings**

Face masks - from 6pm, Friday 29 October 2021

Face masks must be **carried at all times and worn indoors** throughout Victoria except if at home, or when visiting an intimate partner's place of residence or if an exemption applies. Face masks will **no longer be required to be worn outdoors**. However, it is **highly recommended** that masks continue to be worn outdoors where you cannot physically distance.

Working from Home - from 6pm, Friday 29 October 2021

For those who are **not authorised workers** performing work covered under the COVID-19 Mandatory Vaccination (Workers) Directions, the work settings move from *"must work from home"* to *"work from home if you can; OR Go to work if you are fully vaccinated"*.

There is **no change to the current vaccination status requirements** for those authorised to work outside their home under the COVID-19 Mandatory Vaccination (Workers) Directions.

#### Density quotients - from 6pm, Friday 29 October 2021

Density quotients in shared spaces and publicly accessible areas of 1 person per 4 square metres (DQ4), subject to the following:

- All retail Open with DQ4
- Food and drink facilities: open for seated service only indoors. Where customers and staff are fully vaccinated: DQ4 indoors and DQ2 with maximum of 500 outdoors and up to 25 people before DQ applies. Otherwise: DQ4 with maximum of 10 indoors and 30 outdoors.

Food courts open at DQ4, with masks able to be removed to consume food and drink.

**Note:** A business operating under the fully vaccinated arrangements must ensure that a worker is located at each entrance to the premises in the capacity of a COVID-Check-in Marshal, who will ensure that patrons (16 years and over) show acceptable evidence that they are either fully vaccinated or an excepted person.

 Office work environments – DQ2 for areas non-accessible to public. Masks to be worn indoors.

#### **QR Code Requirements**

The electronic record keeping requirements through Victorian Government QR Code Service continue to apply throughout Victoria. The requirement to make reasonable efforts to ensure people check-in and to prominently display QR Code signage at each entrance remains unchanged.

#### **COVIDSafe Plan**

COVIDSafe Plans are mandatory for **all** Victorian workplaces. VACC recommends that COVIDSafe Plans should be **reviewed to ensure it is tailored to your business and remains up-to-date**; and that face covering, cleaning, signage, record-keeping and other requirements applicable to your business (including response to suspected or confirmed case of COVID-19 at the work premises) are being adhered to and communicated with all relevant staff.
