Christmas Day in Victoria – Sunday, 25 December 2016 declared a public holiday

The Victorian Government announced last Friday, 25 November 2016 that it has reversed its controversial decision to not prescribe Christmas Day as a public holiday in Victoria. The reversal of the Government's original decision means that Christmas Day, which falls on Sunday, 25 December 2016, will be treated as a public holiday for the purpose of calculating wage rates for employees required to work on this day.

The Tuesday following Christmas Day (Tuesday, 27 December) will remain as the substitute public holiday for Christmas Day. This means that Sunday, 25 December, Monday, 26 December (Boxing Day) and Tuesday, 27 December will all be public holidays in Victoria this year.

Restricted trading applies on Christmas Day, but not on Boxing Day or Tuesday's substitute public holiday. The public holidays and trading arrangements are attached for your convenience.

Holiday trading arrangements - Victoria

PUBLIC HOLIDAYS	SERVICE STATIONS, ROADHOUSES, TOWING AND ROADSIDE REPAIRS, AND CAR RENTAL ESTABLISHMENTS	NEW AND USED CAR SHOW ROOMS & YARDS, MOTORCYCLE ESTABLISHMENTS, WORKSHOPS, WRECKERS, CAR WASHING ESTABLISHMENTS, MOTOR CAR PARTS AND ACCESSORIES
Sunday, 25/12/2016 CHRISTMAS DAY	May trade	No trading if more than 20 employees AND at any time during the period of 7 days immediately before that time, the number of persons employed by the business and its related entities is no more than 100* (a full-time equivalent basis)
Monday, 26/12/2016 Boxing Day	May trade	May trade
Tuesday 27/12/2016 Substitute for CHRISTMAS DAY	May trade	May trade
Sunday, 1/1/2017 New Year's Day	May trade	May trade
Monday, 2/1/2017 additional day for New Year's Day	May trade	May trade

*For the purposes of calculating the 100, employees employed in branches or in associated businesses count.

Penalty rates of pay apply to employees required to work on the above public holidays as follows:

- All employees except console operators, driveway and roadhouse attendants and casuals employed in any classification: **Double time and a half**
- Console operators, driveway and roadhouse attendants employed on a full time or part time basis (i.e. weekly hired): Double time
- Casual console operators, driveway, and roadhouse attendants:

Flat rate applicable to Saturday, Sunday and public holidays is payable

- Vehicle Salespeople: By mutual agreement a day off in lieu, otherwise double time and a half rates will apply.+
- Other casuals (working in any class of work): **175 per cent loading**

+Double time and a half for salespersons means:

• If more than half a day is worked, half of the salesperson's weekly rate of pay calculated as follows:

Weekly wage rate is \$783.30, they get an additional \$234.99 (which is \$783.30 divided by 5 = \$156.66 x 1.5))

• If half a day or less is worked, one quarter of the salesperson's weekly rate of pay calculated as follows:

Weekly wage rate is \$783.30 they get an additional \$117.50 (which is half of \$234.99).
