Melbourne, **6 September** – Business owners in the automotive industry now have a comprehensive guide to help protect against unfair contract terms, thanks to the Motor Trades Association of Australia (MTAA).

The new legislation – which comes into effect on 10 November 2023 – amends the Competition and Consumer Act 2010 (Cth) and the Australian Securities and Investment Commission Act 2001 (Cth) to impose penalties for proposing or relying on unfair contract terms. Ensuring standard form contracts do not contain any unfair contract terms is now even more important.

MTAA's guide can assist business owners in all sectors of the automotive industry to ensure they're ready for the unfair contract terms changes.
