Public Holiday: Queen's birthday 2022

The Queen's Birthday, Monday, 13 June 2022, is a holiday throughout Victoria and Tasmania.

Trading hours and penalty rates of pay for Queen's Birthday are as follows:

Roadhouses, Towing,	New and used car showrooms and yards, motorcycle establishments, Workshops, car washing &, parking establishments, tyre retailers, boats, caravans, trailers, dismantlers and recyclers
May trade	May trade

Penalty Rates of Pay

Penalty rates of pay for work performed on Public Holidays under the Vehicle Repair, Services and Retail Award 2020 apply **unless the employer and employee have agreed to substitute another day for the public holiday**. The penalty rates are as follows:

	250 per cent of the minimum hourly rate
All casual employees, except console operators, driveway, roadhouse attendants and vehicle salespersons	275 per cent of the minimum hourly rate
Full time and part time console operators, driveway and roadhouse attendants employed on a full-time basis (i.e., weekly hired):	200 per cent of the minimum hourly rate
Casual console operators, driveway, and roadhouse attendants:	Flat rate applicable to Saturday, Sunday and public holidays is payable
Vehicle Salespeople – full time and part time	Double time and a half *
Casual Vehicle Salespeople	275 per cent of the minimum hourly rate of pay

*Double time and a half for full time and part time salespersons means:

- If more than half a day is worked, half of the salesperson's minimum weekly rate of pay
 prescribed under the Award e.g., \$899.50 divided by two, which equates to \$449.75 for the
 public holiday worked.
- If half a day or less is worked, one quarter of the salesperson's minimum weekly rate of pay prescribed under the Award e.g., \$899.50 divided by four, which equates to \$224.88 for the public holiday worked (rounded to the nearest cent)

For example, a vehicle salesperson employed on a 38-hour week at a minimum hourly rate of \$23.67 per hour (i.e., \$899.50 per week), would be entitled to 30.4 hours @ \$23.67 (i.e., \$719.57) plus either \$449.75 or \$224.88, depending on the number of hours worked on the public holiday (i.e., more than half a day or less than half a day is worked).

The relevant amount provided above is in addition to the appropriate minimum hourly rate paid to employees for hours worked during the remainder of the week.

Clerks - Private Sector Award 2020

Employees covered by the Clerks Award will also be entitled to double time and a half rates for working on the public holidays unless the employer and employee have agreed to substitute another day for the public holiday.

VACC recommends that the details of any agreed substitution should be retained in writing.
